The undersigned incorporator Alan Lee Adams, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE 1: NAME

The name of the corporation shall be ADAMS MARINE SERVICE, INC.

#### **ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:
