ARTICLES OF INCORPORATION OF EDELIN AND SONS, Inc.

N SECRETARY OF STATE TALLAHASSEE, FLORIDA

We the undersigned incorporator(s), for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation:

<u>ARTICLE I</u>

Name. The name of the Corporation shall be EDELIN AND SONS, Inc.

ARTICLE II

<u>Business and Activities</u>. This corporation may, and is authorized to engage in any activity or business permitted under the laws of the United States and the State of Florida, including but not limited to automobile repair services for use by individuals and/or businesses in the public and private sector.


