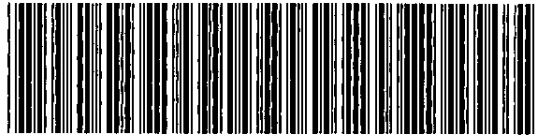

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is **McAlpin Dental Group, P.A.**

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 2301 Park Avenue, Suite 201, Orange Park, Florida 32073.

ARTICLE III

Duration

This corporation shall exist perpetually. Corporate existence shall commence as of January 1, 2009.

ARTICLE IV

Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business, specifically the practice of dentistry.

ARTICLE V

Capital stock

(a) **Authorized Capital.** The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.

(b) **Restrictions on Transfer of Stock.** The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such

restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE VI

Initial Registered Office and Agent

ARTICLE VII

Directors

(a) **Number**. This corporation shall have no directors initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.

(b) **Indemnification**. The board of directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.
