ARTICLES OF INCORPORATION

I, the undersigned, hereby execute this document for the purpose of becoming a professional association for profit under the provisions of the laws of the State of Florida, and pursuant to the following articles of incorporation:

ARTICLE I

The name of the professional association ("P.A.") shall be KIRK O'KONSKI, P.A.

ARTICLE II

The physical business address, the mailing address, as well as the principal office of the P.A. shall be: 4321 Highland Oaks Circle, Sarasota, FL 34235.

ARTICLE III


