

# ARTICLES OF INCORPORATION OF NEW LIFE SPECTRUM, INC.

The undersigned hereby adopts the following Articles of
Incorporation for the purpose of forming a Corporation under the laws of
the State of Florida.

#### ARTICLE I - NAME
