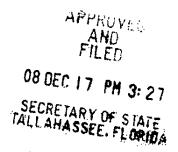

ARTICLES OF INCORPORATION

OF

HERNANDO TITLE SERVICES OF BROOKSVILLE, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation

Act, does hereby adopt the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of this corporation is:

HERNANDO TITLE SERVICES OF BROOKSVILLE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of State of the State of Florida.

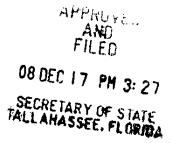
