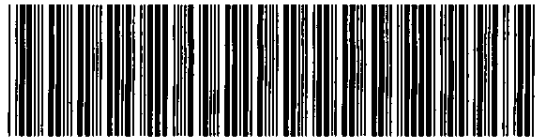

ARTICLES OF INCORPORATION OF Dasix, Inc

The undersigned subscribers to these article of Incorporation, each a natural person competent to contract hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation is: Dasix, Inc.

ARTICLE II

The general nature of the business or businesses to be transacted by this corporation is the following, namely:

- (a) To own and/or operate a consulting service business, provide web services, provide financial services, provide real estate service, network services and installations, provide consumer services, retail store, consignment store, or any store or storefront serving the consuming public. To engage generally in the business or ownership and operation of retail store, consignment store or any store or storefront serving the consuming public for profit.
- (b) To acquire all real property and equipment necessary to conduct such business or businesses and to do every thing commonly done by those conducting a similar business.
- (c) To borrow money for the business of the corporation, and for any and all purposes and obligations upon such terms as the Board of Directors may determine.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) SHARES of common stock without nominal or par value. The consideration to be paid for each share shall be fixed by the Board of Directors.


