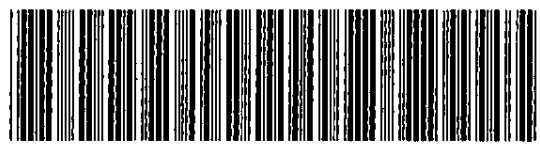

In compliance with the requirements of F.S. Chapter 621, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is FORECLOSURE DEFENSE ATTORNEYS, P.A.

ARTICLE II

The existence of the Corporation shall begin on: December 14, 2008.

ARTICLE III

The street and mailing address of the principal office of the Corporation is: 150 Cocoa Isles Boulevard, Suite 404, Cocoa Beach, Florida 32931.

ARTICLE IV

The specific purpose for which the Corporation is organized is: a joint venture between George M. Gingo, P.A. and Faro and Associates, P.A. to provide legal representation to homeowners in mortgage foreclosure lawsuits and provide bankruptcy representation.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 2000, par value \$0.50 per share, all of which shall be Common Shares. 
