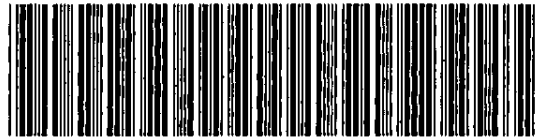

OF

ARTICLE I. NAME

EFFECTIVE DATE 1/1/09

The name of this corporation is EVERYTHING SALES AND SUCH, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2009, and shall have perpetual existence.
