ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF

HELP FOR HOMEOWNERS NOW, INC., a Florida corporation (the "Corporation"), under its corporate seal and through its shareholders, and pursuant to Section 607.1006, Florida Statutes adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I


The following amendment to change the name of the Corporation was approved and adopted by the shareholders, in accordance with Chapters 607, Florida Statutes, as evidenced by the signature herein.

The name of the Corporation shall henceforth be R.R.M.C., Inc., a Florida corporation.

This amendment was adopted and approved by unanimous vote of the shareholders of the corporation at a special meeting of directors and shareholders held September 15, 2009. The number of shareholders present and votes cast for the amendment by the shareholders was sufficient for approval.
