



The private property of the stockholders shall not be subject to payment of the Corporate debts to any extent.

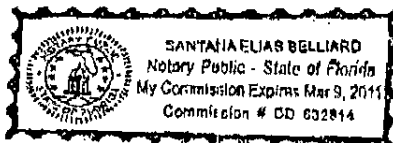
