**ARTICLES OF INCORPORATION**

**OF**

**NCJ-GK HOLDINGS, INC.**

The undersigned, acting as the incorporator of NCJ-GK Holdings, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is: NCJ-GK Holdings, Inc.

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal business office and mailing address of the corporation is 1320 E. 9th Avenue, Tampa, Florida 33605.

**ARTICLE III. CAPITAL STOCK**
