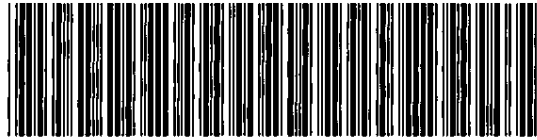

ARTICLES OF INCORPORATION
OF LAB PHARMACEUTICALS CORP.

ARTICLE I-NAME

The name of this Corporation is Lab Pharmaceuticals Corp.

ARTICLE II-DURATION

The Corporation shall have perpetual existence commencing on the date of filing:

ARTICLE III-PURPOSE

ARTICLE VIII-INDEMNIFICATION

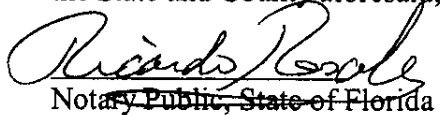

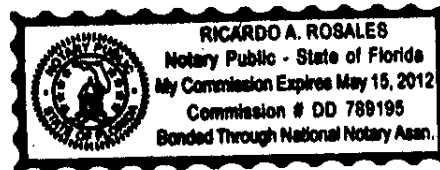
