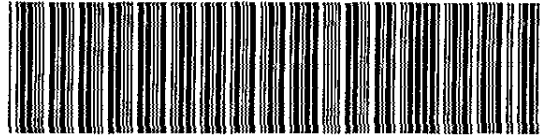

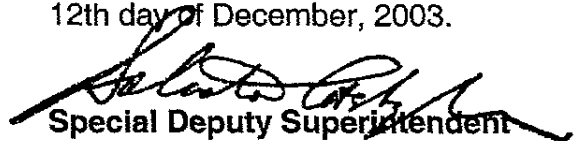

CERTIFICATE OF AMENDMENT
OF
CHARTER OF FIRST COMMUNITY INSURANCE COMPANY
UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW AND
UNDER SECTION 1206 OF THE INSURANCE LAW

The undersigned, being the President and Secretary of First Community Insurance Company, do hereby certify and set forth:

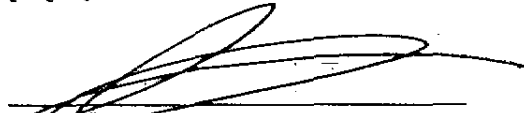
1. The name of the corporation is First Community Insurance Company. The name under which the corporation was previously known was Bausch & Lomb Insurance Company and the corporation was originally formed as SOFLENS Insurance Company.
2. The Declaration of Intention and Charter of First Community Insurance Company was filed with the State of New York Insurance Department on June 7, 1971.
3. The Charter of First Community Insurance Company is hereby amended to change the name of the corporation and to change its principal office location.
4. Paragraph 1 of the Charter, which sets forth the name of the corporation, is hereby amended to read as follows:
 1. The name of the corporation shall be Fidelity National Property and Casualty Insurance, Inc.
5. The manner in which the foregoing amendment of Paragraph 1 was authorized was by affirmative vote of all the directors of First Community Insurance Company by written consent in lieu of a meeting dated November 10, 2003 and by affirmative vote of the holder of all outstanding shares entitled to vote thereon by written consent in lieu of a meeting dated November 10, 2003.

6. Paragraph 2 of the Declaration of Intention and Charter which sets forth the principal office location is hereby amended to read as follows:

2. Its principal office shall be located in the County of New York,
New York.

7. The manner in which the foregoing amendment of Paragraph 2 was authorized was by affirmative vote of all the directors of First Community Insurance Company by written consent in lieu of a meeting dated July 16, 2003.
