

CERTIFICATE OF AMENDMENT

OF

CHARTER

OF

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW AND UNDER SECTION 1206 OF THE INSURANCE LAW

The undersigned, being the President and Secretary of Fidelity National Property and Casualty Insurance, Inc., do hereby certify and set forth:

- 1. The name of the corporation is Fidelity National Property and Casualty Insurance, Inc. The names under which the corporation was previously known were First Community Insurance Company and Bausch & Lomb Insurance Company. The corporation was originally formed as SOFLENS Insurance Company.
- 2. The Declaration of Intention and Charter of Fidelity National Property and Casualty Insurance, Inc. was filed with the State of New York Insurance Department on June 7, 1971.
- 3. The Charter of Fidelity National Property and Casualty Insurance, Inc. is hereby amended to change the name of the corporation.
- 4. Paragraph 1 of the Charter, which sets forth the name of the corporation, is hereby amended to read as follows:
 - 1. The name of the corporation shall be Fidelity National Property and Casualty Insurance Company.

5. The manner in which the foregoing amendment of Paragraph 1 of the Charter was authorized was by affirmative vote of all the directors of Fidelity National Property and Casualty Insurance, Inc. by written consent in lieu of a meeting dated January 14, 2004, and by affirmative vote of the holder of all outstanding shares entitled to vote thereon by written consent in lieu of a meeting dated January 14, 2004.
