Pursuant to Section 490.1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following Amendment to its Articles of Incorporation.

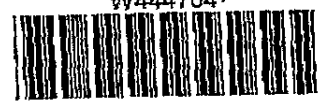
1. The name of the corporation is Ruan Leasing Company.
