

ARTICLES OF INCORPORATION BRIGHT FUTURE ELECTRIC HOLDINGS, II

EMEARS PIZE The undersigned hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation is BRIGHT FUTURE ELECTRIC HOLDINGS, INC., and its principal place of business and mailing address is 630 Kissimmee Avenue, Ocoee, Florida 34761.

ARTICLE II **Existence of Corporation**

This corporation shall begin existence on the date of filing of these Articles with the Secretary of State, Division of Corporations for the State of Florida and shall have perpetual existence.
