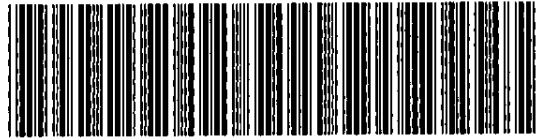

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is TALLAHASSEE INFORMATION TECHNOLOGY, INC. and its principal place of business shall be located at 4450 Scawthorn Road, Tallahassee, Florida 32303, and is a for-profit Florida corporation.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock at Ten Dollars (\$10.00) par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS
