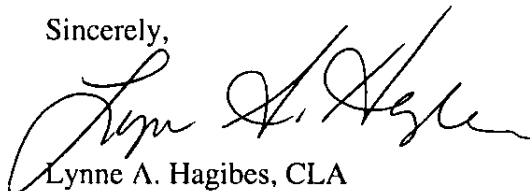

The undersigned, desiring to form a professional corporation under the provisions of the laws of the State of Florida, hereby make, subscribe and acknowledge before a notary public, and file with the Secretary of State of the State of Florida, the following Articles of Incorporation for such professional corporation:

ARTICLE I - NAME

Effective Date *12-12-08*

The name of the professional corporation is: GLORIA M. BARREDO, D.M.D., P.A.

ARTICLE II - PURPOSE

This professional corporation is organized for the following purposes:

- (A). To engage in the practice of the profession of dental medicine and to carry on services incident thereto. The practice of dentistry is the sole and exclusive professional service to be rendered by this corporation.
- (B). To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
- (C). The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom shall be authorized to engage in these professional services.

ARTICLE III - DURATION

This corporation shall exist on a perpetual basis commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE IV - CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 100 shares. Such shares shall be of a single class of common stock and shall have a par value of \$1.00 per share.
