# **ARTICLES OF INCORPORATION**

The undersigned subscribe to these Articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### **ARTICLE I**

NAME: The name and address of this Corporation is:

## ARTICLE II

## NATURE OF BUSINESS:

- (a) The general nature of the business of the corporation shall be painting to interior and exterior of buildings.
- (b) To purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of or invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- (c) To conduct business in, have one or more offices in, the State of Florida and all other states and countries, to buy, to hold mortgage, sell, convey, lease, or otherwise dispose of franchise, patents, copyrights, trademarks and licenses.
- (d) To conduct debts and borrow money, Issue or sell or pledge bonds, debentures, notes, and other evidence of indebtedness, and execute such mortgages, transfer of corporate indebtedness as required.
- (e) To guarantee, endorse, purchase, hold, sell, transfer mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock, of or any bonds, security or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while the owner of such stock, to exercise all the rights, power, privileges of ownership, including the right to vote on such stock.

(f) To purchase the corporate assets of any other corporation and engage in the same nature or character of business.

## **ARTICLE III**

The total number of shares of capital stock, which may be issued by this corporation, shall be 1000 shares at \$1.00 par value each, all of which shall be common stock and shall be fully paid and non-assessable. All such stocks shall be payable in cash, property, and labor or service at a just valuation to be fixed by the Board of Directors to a meeting called for that purpose.

## ARTICLE IV

The amount of capital with which this corporation will begin business is not less than One Thousand Dollars (\$1000.00). The shares shall be issued as follows:

## **ARTICLE X**

<u>Voting Rights</u>: Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holder of the outstanding common shares.

#### **ARTICLE XI**

<u>Preemptive rights:</u> Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as the which he already holds, shall have the right to purchase his / her pro rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
