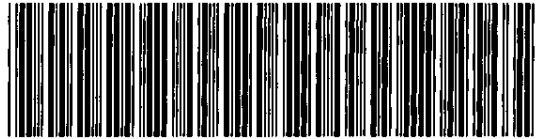



ARTICLES OF INCORPORATION
OF
TENTH STREET PROMOTIONS, INC.

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **TENTH STREET PROMOTIONS, INC.**

ARTICLE TWO

The period of its duration is perpetual.




