## ARTICLES OF INCORPORATION OF JTD Fun, Inc.

#### **ARTICLE I - NAME**

The name of this corporation is JTD Fun, Inc. located at, 410 West Merritt Avenue, Merritt Island, Florida 32953.

#### <u>ARTICLE II - DURATION</u>
