ARTICLE I - NAME

The name of this corporation is USA Factoring Corporation

ARTICLE II - PURPOSE

This corporation is organized for the purpose of buying and selling accounts receivable and transacting any or all lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 7500 shares of \$1.00 par value Common Stock, which shall be designated as "Common Shares."
