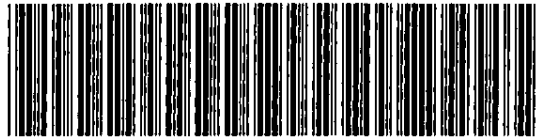

ARTICLE I

Name

The name of this corporation is:
