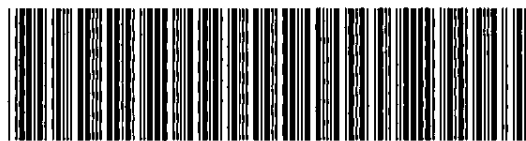

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE ONE**  
**NAME**

The name of the corporation is **INTER EXPRESS TRUCKING INC.**

**ARTICLE TWO**  
**CORPORATION DURATION**

The duration of the corporation is to be perpetual.

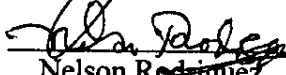
