## ARTICLES OF INCORPORATION OF

#### ATLANTIC FLORIDA ELECTRIC, INC.

The undersigned, acting as incorporator of ATLANTIC FLORIDA ELECTRIC, INC under the Florida General Corporation Act, adopts the following Articles of Incorporation.

#### **ARTICLE I. NAME**

The name of the corporation is: ATLANTIC FLORIDA ELECTRIC, INC. The principal place of business of this corporation shall be:

#### ARTICLE II. COMMENCEMENT OF EXISTENCE

#### **ARTICLE III PURPOSE**

The nature of the business or purposes to be conducted or promoted is to engage in any and all lawful act of General Corporation Law of Florida, including without limitation the ability to and engage in all other matters incident thereto.

#### **ARTICLE IV. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

#### ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VI. INITIAL BOARD OF DIRECTORS



#### **ARTICLE VIII. BYLAWS**
