

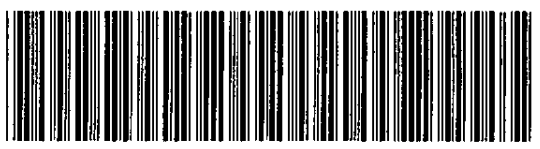

ARTICLE I - NAME

The name of this corporation is GOLD GETS U CASH, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.






