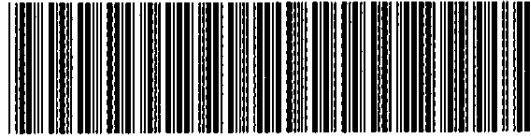

## **Article VI:**

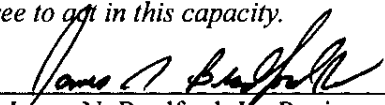

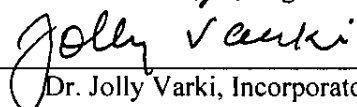
