



## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Hereby adopts the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of this corporation is D A BARNES ASSOCIATES, INC.
