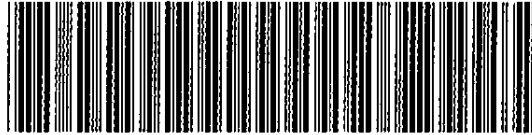



# ARTICLES OF INCORPORATION OF D A BARNES ASSOCIATES, INC.

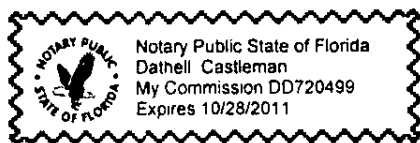
