

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Florida Technologies Investment Fund, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 8885 Highway A1A Melbourne Beach, Florida 32959

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
