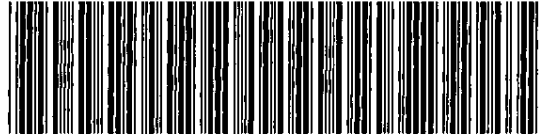

# ARTICLES OF INCORPORATION FOR NATIONAL PROFESSIONAL SERVICES, INC.
