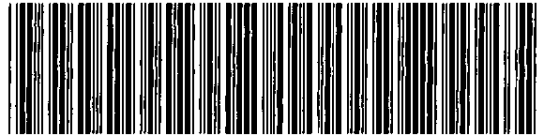

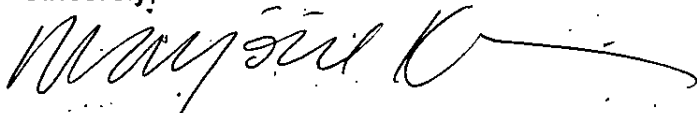

**ARTICLES OF INCORPORATION
OF
JACOBI & KLEIN, P.A.**

We the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

Article I
Name

The name of the Corporation is **Jacobi & Klein, P.A.**

Article II
Principal Office and Address

The address of the principal office and mailing address of the Corporation is 11077 Biscayne Blvd., Suite 200, Miami, Florida 33161.

Article III
Duration

The term of existence of the Corporation shall be perpetual, and the corporate existence will commence on the filing of these articles by the Department of State.

Article IV
Purpose

The purpose for which this Corporation is organized is the general practice of law under the laws of the State of Florida, any and all lawful business necessary or incidental thereto and all powers conferred by the laws of the State of Florida.

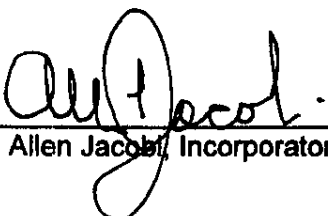
