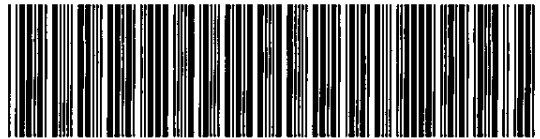

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is DALE JONES CORP.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose for which the corporation is organized is to engage in any activity or business permitted under laws of the United States and of this state.

FOURTH: Authorized Shares.

Number. The aggregate number of shares that the corporation shall have the authority to issue is 100 shares of Capital Stock with a par value of ten dollars per share.

FIFTH: The initial street address in Florida of the principal office of the corporation is 506 West Belmar Street, Lakeland, Florida Initial Agent is Dale Jones registered at such address is 506 West Belmar Street, Lakeland, Florida 33803.

SIXTH: The initial board of directors shall consist of one member(s). Directors need not be residents of the State of Florida or shareholders of the corporation.

SEVENTH: The names and address of the persons who shall serve as directors until the first annual meeting of the Corporation, or until successors shall have been elected and qualified, are as follows:

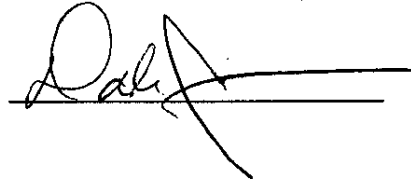

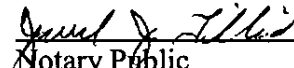

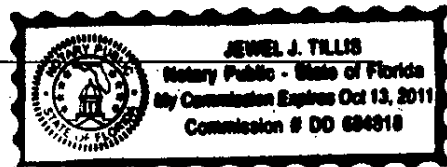
