ARTICLES OF INCORPORATION

OF

RICHARDSON KLEIBER WALTER KLEIBER BUTTON, INC.

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **RICHARDSON KLEIBER WALTER KLEIBER BUTTON, INC.**

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

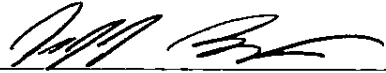
ARTICLE EIGHT

ARTICLE TEN

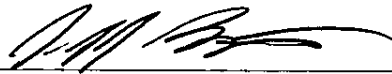
The powers of the incorporators cease upon filing the Articles of Incorporation.
