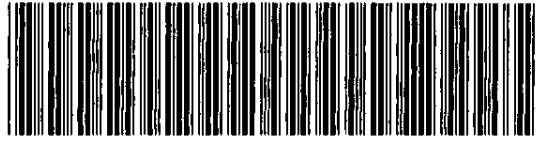

ARTICLES OF INCORPORATION

OF

SOUTHERN DESIGN & HOTEL SUPPLY, INC.

ARTICLE ONE

The name of the corporation is SOUTHERN DESIGN & HOTEL SUPPLY, INC.
