**ARTICLES OF INCORPORATION FOR
A & O EIGHT, INC.**

The undersigned, the authorized representative of the shareholders of the Company formed under Chapter 607, Florida Statutes (2002), adopts the following Articles of Organization for such Company ("Company"):

ARTICLE I

Name

The name of the Company is **A & O Eight, Inc.**

ARTICLE II

Place

The principle place of business is at 5435 Flintwood Court, Pensacola, Escambia County, Florida, 32504.

ARTICLE III

Purpose

The Purpose of the Company is to purchase and resell real estate, improved or unimproved, to the public and all other interested buyers. The new company is for profit and will file an 1120 Federal Tax Return. The new company will begin business and become legally effective on January 20, 2009.

ARTICLE IV

Shares of Stock

The Company shall authorize and issue one-thousand (1,000) shares of common stock. This is the only class of stock; all holders of shares have voting rights. The shareholders and number of shares owned by each shareholder are as follows: Ms. Zeal Anawim Beale, 5435 Flintwood Court, Pensacola, Florida, 32504, 501 shares of stock; Ms. Jessica Anne Marie Beale, 13322 Maxella, #7, Marina Del Ray, California, 90292, 250 shares of stock, and Benjamin Jacob Beale, 104 West Golf Drive, Stillwater, Oklahoma, 249 shares of stock. All shareholders are of majority age and are citizens of the United States of America. No other persons or entities have

been issued any shares. Shares may be bought or sold to other persons or entities at a cost of no less than \$100.00 per share.

ARTICLE V

Officers and Directors

The remaining shareholder or shareholders of the Company may continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or the occurrence of any other event which terminates the continued ownership rights of a shareholder in the Company. Ms. Zeale Anawim Beale is the only Director of the company at the time of incorporation; there are no officers of the Company.

ARTICLE VI
