Articles of Incorporation for

Vinca Grinding and Machining, Inc.

(for-profit corporation)

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be Vinca Grinding and Machining, Inc.

ARTICLE II - PURPOSES

ARTICLE XI - INDEMNITY OF DIRECTORS AND OFFICERS

ARTICLE XII - BY-LAWS AND STOCKHOLDERS AGREEMENT
