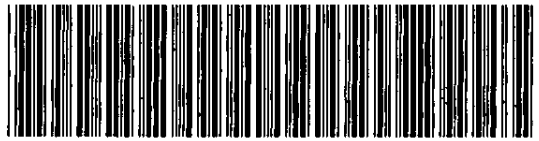

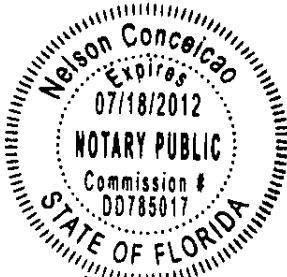
ARTICLE XII


