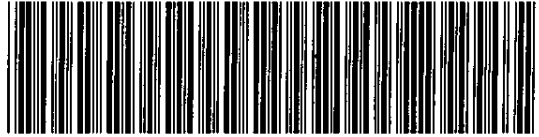



## **The Maker's Market, Inc.**

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation :

Article 1. Name. The name of the Corporation is **The Maker's Market, Inc.**

Article 2. Purpose. The general purposes for which the Corporation is organized are the following :

- A. To engage in and offer in exchange for a reasonable fee, services such as, but not limited to, educational classes, lectures or workshops, the specialized service of consultation and the exchange of information and/or referral to other resources by way of community events.
- B. To engage in and transact in, any and all lawful business for which Corporations may be incorporated under the Florida General Corporations Act. No other purpose limits this purpose in any way.
- C. To do such things as are incidental to the purposes of the Corporation or necessary or desirable to accomplish them.

Article 3. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

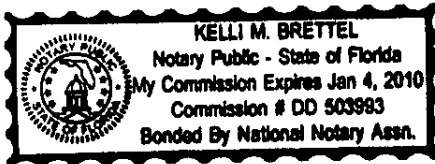
