ARTICLE 1 - NAME

The name of the corporation is Artesani Management Services, Inc., a Florida corporation.

ARTICLE 2 - PRINCIPAL OFFICE

ARTICLE 4 - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE 11. - INDEMNIFICATION

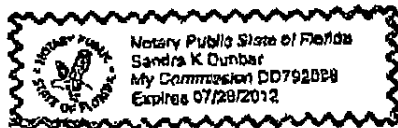
