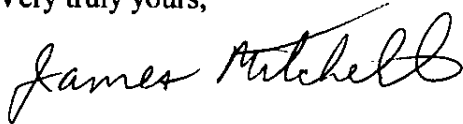

extent permitted by law.

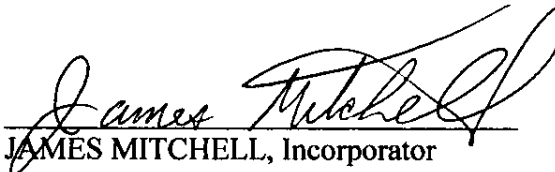
ARTICLE XII: BYLAWS

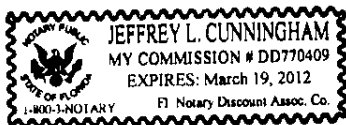

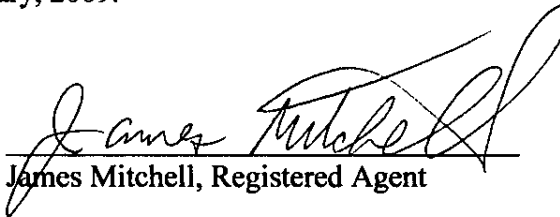
