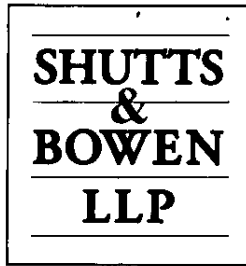

This letter is intended to clarify what we are trying to accomplish to ensure the filings are performed correctly. It is very important that the documents all be filed at the same time (but with the dissolutions preceding the new filings) so please do not process any of the documents until you are able to verify that all documents can be filed as submitted.

The documents submitted for filing are as follows:

1. Articles of Dissolution for Shoquist Enterprises a Florida Corporation with a check for \$35.00. ✓

2. Application by Foreign Corporation For Authorization to Transact Business in Florida for Shoquist Enterprises, a Delaware Corporation with a check for \$1,828.75, which includes the fee for a certificate of status. ✓

Also enclosed is the Certificate of Status from the State of Delaware. ✓

A new articles of incorporation were inadvertently filed by the incorporator, instead of an application for an existing foreign corporation for authority to do business ✓

in Florida. You will note that the dissolution is irrevocable, so the name should become immediately available.

3. Certificate of Dissolution for Shoquist Family Limited Partnership, a Florida Limited Partnership with a check for \$52.50. ✓

4. Application by Foreign Limited Partnership For Authorization to Transact Business in Florida for Shoquist Family Limited Partnership, a Georgia Limited Partnership with a check for \$1,008.75, which includes the fee for a certificate of status.

A new certificate of limited partnership was inadvertently filed by the partnership instead of an application for an existing foreign limited partnership for authority to do business in Florida. You will note that the dissolution is irrevocable, so the name should become immediately available. ✓

5. Articles of Dissolution for Pelican View Project, an LLC formed in February of 2009, with a check for \$25.00. ✓


6. Limited Liability Company Reinstatement Form for Pelican View Project, an LLC formed in January of 2005, along with a check for \$660.00, which includes a fee for a certificate of status. ✓

A new limited liability company was inadvertently formed instead of a reinstatement of an existing limited liability company. You will note that the dissolution is irrevocable, so the name should become immediately available. ✓

It would be greatly appreciated if the documents could be filed as soon as possible and the certificates of status (3) returned in the enclosed Federal Express pack as soon as they are available.
