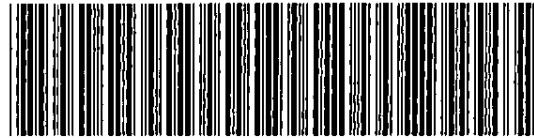

The Name of the corporation shall be **G7G, INC.**, whose principal office shall be located 1310 Silver Moon Court, Tallahassee, Florida 32312.

II

The duration of the corporation shall be perpetual.

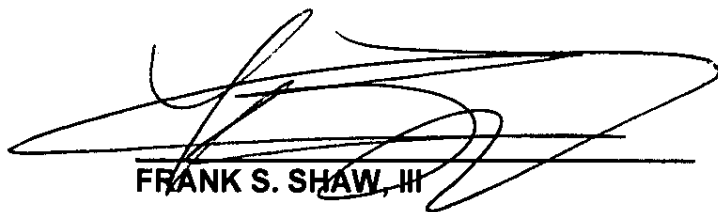
