ARTICLES OF INCORPORATION OF MAZIE'S GRUB SPOT, INC.

The undersigned, incorporator, for the purpose of forming a corporation object the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLES I: NAME OF THE CORPORATION
