**ARTICLES OF INCORPORATION**

**Article I - Name**

The name of this corporation is:

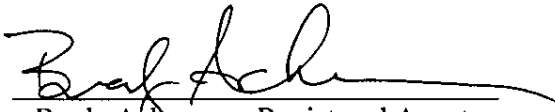
Article VIII - Indemnification
