I, Alfredo Morales, a Florida citizen, formed a Florida corporation called Vector Limited, Inc. on February 5, 2009, with document #P09000011837. Articles of Incorporation Exhibit A

I used my personal information, obtained a federal EIN number for the Company, EIN: 26-4203818.

The Company did not engage in business and I allowed the Florida Division of Corporations to involuntarily dissolve the entity in September 2011.

Without authorization, knowledge or notice to me, some unknown person who is or used the identifier "Steven Kuhnlein" and "William Fusco" contacted the Florida Division of Corporations to (i) reinstate the Company as an active corporation on or about April 27, 2016, (ii) pay the reinstatement expense for five (5) years (2011 - 2016) to the Florida Division of Corporations; and (iii) falsely assume the identity of the Company by stating "Steven Kuhnlein" is a "Vice President" with an address at 447 Raven Court, Brownsburg, IN 46112, and "William Fusco" is a "Treasure" with an address at 42 Mustang Drive, Guilford, CT 06437. Attached Exhibit B is the annual report filed with the Florida Division of Corporations showing these actions, but also leaving myself identified as President and Registered Agent of the Company, and leaving my home listed as the principal address of the Company.

With learning of this false taking of the Company, I filed my resignation as president and registered agent with the principal address of the Company, and put the world on notice of this fraud. See attachments Exhibit C and Exhibit D.

I have been damaged to date by the out-of-pocket expenses of legal counsel and filings fees with the Florida Division of Corporations.

I do not have knowledge of how the Company is being used by these unknown person(s) who have falsely taken over the identity of the Company.
