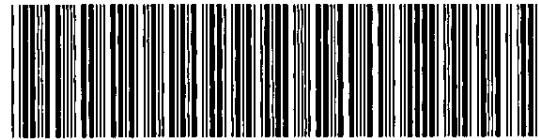

**ARTICLE I**

**PURPOSE:**

The general nature of the business to be transacted by this corporation shall be:

The number of directors may be altered from time to time by By-Laws adopted by the Shareholders. However, the Corporation shall have no less than one (3) Director at any time.



This provisions shall be in addition to any other rights to which those indemnified may be entitled under any By-Laws , agreements , vote of shareholders or otherwise , disinterested directors or otherwise, both as to action in his official capacity and is to continue as to any person who has ceased to be a director or officer , and shall inure to the benefit of the heirs , executors and administrators of such a person.
