ARTICLE I

Name and Duration

AFER O MID: 22 The name of the Corporation is Fishing Creek Community Association, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the principal office and mailing address of the Corporation in the State of Florida is 14 East Bay Street, Jacksonville, Florida 32202.

ARTICLE III

Registered Office and Agent

<u>ARTICLE IV</u>

Corporate Purposes, Powers and Rights

- The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
- In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.
