ARTICLE I - NAME

The name of this Corporation is Superior Accessories, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on February 9, 2009.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK
